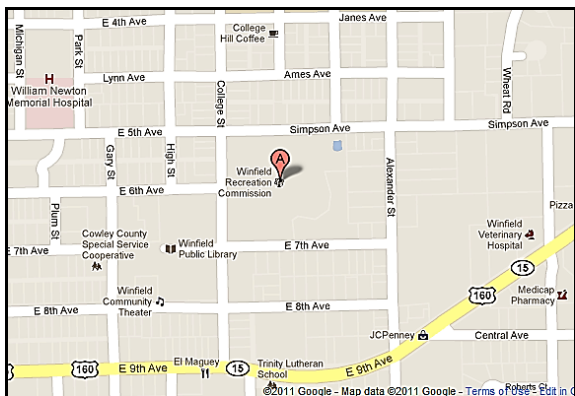
The Walnut Valley Metric routes travel through scenic Cowley County on gently rolling hills and lightly traveled secondary roads.

I acknowledge that by signing this document I am releasing Prairie Travelers, Inc. (PTI), Oz Bicycle Club (OBC) and others from liability. THIS IS A CONTRACT WITH LEGAL CONSEQUENCES. I HAVE BEEN ADVISED TO READ IT CAREFULLY BEFORE SIGNING.

In consideration of PTI/OBC allowing my participation in the Walnut Valley Metric: I acknowledge cycling is inherently dangerous and fully realize the dangers of participating in bicycle rides and FULLY ASSUME THE RISKS ASSOCIATED WITH PARTICIPATION INCLUDING, without limitation; collision with cyclists, pedestrians, vehicles and fixed or moving objects; surface hazards, equipment failure, inadequate safety equipment, THE RELEASED PARTIES' OWN NEGLIGENCE, weather conditions and the possibility of serious physical and/or mental injury.

I HEREBY WAIVE, RELEASE, HOLD HARMLESS, PROMISE NOT TO SUE AND INDEMNIFY OBC/PTI, LAW ENFORCEMENT AGENCIES, ALL PUBLIC ENTITIES AND THEIR AGENTS, OFFICIALS AND EMPLOYEES ("Released Parties") FROM ANY and all rights and CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASED PARTIES' OWN NEGLIGENCE, which I may have for any damages sustained by me in connection with my participation in any event, or travel to or from any event.

I agree, should I assert claims prohibited by this agreement, I shall be liable for expenses (including legal fees) incurred by the defending party unless the defending party is finally adjudged liable. This agreement shall bind my heirs, legal representatives, successors or assigns.
